# **Recruitment notice: Detailed Terms and Conditions**

Punjab Waqf Board seeks applications from eligible candidates for the One post of Guest Faculty in Punjabi Subject for a period of academic session 2024-25 or upto the commencement of summer vacations, in Islamia Girls College, Malerkotla running under the direct management of the Board. The details of the posts in College are mentioned in the advertisement.

# **Essential Qualifications:-**

Master's degree with 55% marks (or an equivalent grade in a point scale wherever grading system is followed) in a concerned subject from an Indian University, or an equivalent degree from an accredited foreign university.

Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission

#### **AGE CRITERIA**

Candidate applying for this post should be not more than 37 years.

## **MODE OF SELECTION**

Candidate shall be selected solely based on their suitability as assessed through merit, subject to fulfillment of eligibility criteria fixed by the UGC and Punjabi University, Patiala.

(A) Academic Record (Total 60 Marks):

1. High School := Max. 4 Marks (1st class = 4, 2nd class = 2, 3rd class = 0) 2. Higher Secondary (10+2) := Max. 6 Marks (1st class = 6, 2nd class = 4, 3rd class = 0) (In case of candidates having passed 11th Board, maximum 5 marks shall be awarded (1st class = 5, 2nd class = 3, 3rd class = 0) 3. Graduation := Max. 16 Marks (Total percentage obtained divided by 10x1.6). In case of 3rd class, zero marks shall be awarded. 4. Post Graduation:= Max. 24 Marks (Total percentage obtained divided by 10x2.4). M.Phil./Ph.D. := Max. 10 Marks (Ph.D. = 10, M.Phil.=6)

- (B) Research Performance (Total 20 Marks): 1. Candidates showing quality publications in international/ national peer reviewed journals (having indexed in recognized abstraction services) and other research publications having ISBN/ISSN/Indexed Journal No. 1 mark per research paper, subject to Max. of 15 marks 2. International/ National Seminar/ Conference attended/ presented research paper 1 mark per International Seminar/ Conference & 0.5 mark per National Seminar/ Conference, subject to Max. of 5 marks
- (C) Teaching Experience (20 Marks): 2 marks for each year of experience up to maximum of 10 years. Experience of teaching in concerned subject in any private/govt/aided college shall be considered.

**Interview** (Constituting 50 marks) shall be conducted for the candidates who are selected after scrutiny of essential qualification and merit acquired as per the academic record, research performance and experience. Final Selection is subjected to interview plus merit score of the candidates (academic record and research performance).

NOTE: If two applicants score equal merit points, the one score higher marks in PG will be preferred.

### SALARY AND OTHER SERVICE CONDITIONS

Candidate shall be engaged for a period of one year at fixed monthly remuneration of Rs 16,500 with the following terms and conditions:
